Summary report, 5 September 2017

Lisbet Thoresen, PLAC – South Chair DOI review of RACs and DAC meetings

In May, the Department of Interior (DOI) suspended all meetings of BLM's advisory boards and councils, including 220 Resource Advisory Councils (RACs) and the Desert District Advisory Council (DAC) in California. The councils were established by FLPMA as a citizens' advisory group in 1976. Inadequate public engagement in some regions was said to have prompted the review and temporary suspension of activities. San Diego Mineral & Gem Society submitted a letter to DOI supporting reinstatement of the DAC meetings, BLM field offices in southern California work hard to make the DAC a productive channel of communication with the public.

The review was originally expected to conclude sometime in September, so BLM staff looked forward to scheduling the next DAC meeting in October or November. At press time, a date certain had not been set.

National Monuments review

Secretary Zinke submitted his final report on DOI's review of 27 national monuments (NM) on August 24. President Trump ordered the review of monuments designated or expanded under authority of the Antiquities Act of 1906 by his three predecessors – Obama, Bush, and Clinton. President Trump has publicly advocated transferring control of federal lands to the states, which would enable them to greenlight commercial development such as mining, oil drilling, and utility-scale renewable energy projects.

Zinke's report was not made public, but a summary issued by DOI reiterated some preliminary recommendations he issued during the review period: no monuments would be abolished, and downsizing would be recommended for "a handful" of monuments.

Three of the monuments are in Southern California: Sand to Snow, San Gabriel Mountains, Mojave Trails. In July-August, Zinke took Sand to Snow off the list of downsizing candidates; however, the fate of the other two is not known.

On June 30th, in a letter to Secretary Zinke, 17 House Republicans, including California representatives Paul Cook (8th district), Darrell Issa (49th district), and Tom McClintock (4th district), advocated eliminating nine monuments and reducing the size of 14 others, including San Gabriel Mountains and Mojave Trails.[See short URL: <https://goo.gl/u5xYBr>] ALAA has supported the recommendation, citing inputs Rockhounds.[See short URL: <https://goo.gl/RgTvaj>]

Mojave Trails's 1.6 million acres is vulnerable to being reduced by as much as one-third. Prior to the monument designation, 600,000 acres that are now within the monument's boundaries had been approved for renewable energy projects. House Majority Leader Kevin McCarthy (R-Bakersfield) and Rep. Paul Cook (R-Inyo, Mono, and most of San Bernardino Counties) favor reducing it significantly, with Rep. Cook looking for a scaling back of at least 500,000 acres to benefit mining and other economic interests, notably Cadiz Inc., which proposes to tap the aquifer beneath the monument and sell it to Orange County.[See short URL: <https://goo.gl/Nvq6if>] Mojave Trails completely surrounds Cadiz's 9,000-acre tract, and it now represents an encumbrance to the company's plans for obtaining the needed right-of-way along the railroad to build the pipeline.

Anticipating the possible downsizing of Mojave Trails to accommodate Cadiz, Inc, on July 5th, Assembly Member Laura Friedman (D-Glendale) introduced AB 1000, the California Desert Protection Act, specifically to stop the company's water extraction project. The bill died in committee on September 1st. Recreational users hoping that Mojave Trails will be downsized and access will revert to what they enjoyed previously may be chagrined to find that fences will go up around all the new-built facilities, including the railroad right-of-way that Cadiz is seeking.

In the meantime, BLM is working on the management plan for Mojave Trails and are looking for a final draft plan ready for public comment and reviews to be released in mid-2019. The roads from the WEMO maps already in BLM's database, will be incorporated into the draft plan. I visited with Peg Margosian last October and additional route data had been entered by Kim Erb and a now-retired BLM geologist (and rockhound.)

What influence Zinke's report has on the President and how events unfold in the coming months is anyone's guess. Conservation and public access advocates promise that scale-backs will engender litigation. One thing is clear from Secretary Zinke's monument review – current public sentiment on the is strongly in favor (99% of respondents) of retaining, growing, and adding national monuments. DOI received 2.9 million letters – more than for any other issue – ever.[See short URL: <https://goo.gl/C3p7hV>]

ONE OF OUR OWN IS HONORED BY AFMS AT AFMS/CFMS BANQUET

The 2017 AFMS Recognition Award was presented at the AFMS/CFMS Annual Banquet held in Ventura, CA to an individual who has been President of the California Federation and has worked long and hard at this level in a leadership role for many years as a Director, Officer, and Committee Chair.

This individual also received the prestigious California Federation’s Golden Bear Award. This individual is a member of the host club, Ventura Gem and Mineral Society. Our recipient served as President as well as 3rd VP – Show Chair; Membership Secretary; 1st VP – Programs; Past President/Parliamentarian; Scholarship Chair and Educational Outreach/Museum Chair.

Our recipient has also served on the AFMS Board of Directors; Scholarship Foundation; and Boundaries Committee, and a judge for the AFMS Bulletin Contest. This individuals’ biggest claim to fame, however, is being Chair of the AFMS Junior Program since 2003 and the CFMS Junior Activity Chair since 1998. Our recipient constructed the AFMS program for juniors; updated the program every four years; and maintains a badge program called the Future Rockhounds of America Badge Program.

Our recipient instituted a program that all clubs can use to teach various age groups in a myriad of subjects such as geology; mineralogy; and gemology just to name a few. Students receive badges a membership patch (3,946 to date), activity badges demonstrating their proficiency in a particular area (currently 20 total badges) and yes our recipient designed all the badges. To date, over 11,900 badges have been handed out. If a student masters all the subjects they are awarded an AFMS pin – a special mark of distinction (28 to date) and the best part is the program is free.

Besides the Badge Program, our recipient uses other tools to help juniors of all individual clubs such as: 1) a menu of Kids Show Activity Suggestions; 2) Earth Science Activity Presentations; 3) the Patricia Egolf Rock Pals Program; and finally 4) our own AFMS Bulletin Contest for Youth Articles.

In his spare time, our recipient is also a regular contributor to Rock and Gem Magazine, the publication that continually supports the mission of the AFMS. Our recipient writes general interest articles for adult readers

and monthly articles aimed at kids, exploring different minerals, fossils, or special topics currently totaling about 200 articles.

In conclusion, I continuously hear members of the AFMS ask how we can best achieve the survival of our hobby. Well what better way than to educate our youth and instill a life-long knowledge and appreciation of all the aspects of our hobby. Therefore, I was pleased to present to **Jim Brace-Thompson** the 2017 AFMS Recognition Award for his outstanding service to the AFMS.
