Then our own Richard Kowaleski [AKA "Reasonable Richard"] will invite us into the mysterious and stunning world only visible via "Stereo Microscopes".


Buyer's Alert! Back in November of last year I gave a presentation on "Lapidary & Carving on a Budget," in which I demonstrated the benefits of using less expensive Harbor Freight Tools in place of the much more costly standard lapidary equipment. Their 10" Industrial Tile/Brick Saw [which I use for slabbing, trimming, & carving] will be on sale June 9, 10, & 11 for only \$209.99. Usually there are HFT 20% off coupons in most coupon mailers or Google "Harbor Freight Tools Coupons". If you can get the discount, then that would drop the price to \$167 !!!

Note: You will also need to purchase their rollable stand [\$60] and a 10" diamond saw blade [\$32]. If you do acquire the saw, please contact me: there is a homemade after-purchase enhancement that I recommend to help when using the saw for lapidary purposes.





The Rookies will meet at 5:30 p.m. June 13, 2017 in the lapidary shop.



Placer County Fairgrounds Renovations — The Latest News

On May 31, nine RRR members attended the “Community Outreach Meeting” presented at the Fairgrounds by **Placer Valley Tourism, the organization which will own the Fairgrounds as of July 1, 2017.**

Many of us wore our club vests and shirts, so we stood out, as a group, from the hundred or so other people who were there.

There was a slide presentation by various public officials and Fair Association board members. We asked many questions afterwards.

Here is a summary of what we think RRR members should know about the coming Fairgrounds changes.

PHASE 1 (a)

- Jones Hall (including the Garden Room) and Johnson Hall will begin renovations on July 5, 2017. Therefore **our club meetings can no longer be held in the Garden Room.**
- **Lauppe Hall will still be available for our meetings** until October or November, at least.
- Access to the Fairgrounds may change. Our current access to the Gate C parking lot via All America City Blvd. will eventually become the “back” entrance to the Fairgrounds, with access to the residential neighborhood rerouted.
- The main entrance to the Fairgrounds will be from Junction & Vallejo, with an improved and widened roadway and traffic signal.
- Corporation Yard Road may be used as a drop off area for Uber, cabs, and private cars.
- Improvements to Jones & Johnson will include redoing the electrical, redoing the restrooms, upgrading the kitchen in Johnson Hall, making the stage in Johnson Hall ADA accessible, and in Jones Hall putting in skylights, new electrical, removing the stage, and having a portable stage available.
- **By spring of 2018, in time for our March Show, we should have access to the refurbished Jones & Johnson Halls.**

PHASE 1 (b) (scheduled for spring of 2018)

- **Lauppe Hall will be demolished**, though they will leave the old oak tree standing. We will probably not have the use of Lauppe Hall for our March Show.
- The 130,000 sq. ft. **Sports Event Center** will be built, where Lauppe Hall is now. New landscaping will be done throughout the Fairgrounds.
- Outside of Johnson Hall in the plaza, there will be spaces for tent-like structures, an idea taken from the Roseville Rock Rollers Show’s outside vendors. The spaces will be paved or bricked, so no more

setting up in the mud or dealing with sloping sites! **See picture on Page 5** for an artist’s drawing of what this will look like.

- **This Sports Event Center (SEC) is the main goal for Placer Valley Tourism (PVT).** They are focused on Business Improvement Districts (BID). Sorry about all those acronyms, but we should all know that the main objective of PVT is to improve the area for the hotel industry, and to attract more outside tourism to the area.
- Our club gets to have a say, no matter how minor, in this improvement because our Shows have brought thousands of people to the Fairgrounds in the past, and we will bring in more in future years.

PHASE 2 (mid-2019)

- Subject to environmental impact reports to look at issues, such as land use, traffic, air quality, green house gas, noise, lighting, etc., another 60,000 sq. ft. will be added to the Sports Event Center.


WHAT YOU NEED TO DO NOW

COLLECTION MATERIAL – Obsidian (various sheen), needles are possible, depending on mining claims.

PROPOSED SCHEDULE - Friday, collect until 5 PM. Saturday, collect until 5 PM

MEET – Plum Valley Campground, leaving to collect at 9 AM sharp.

DIRECTIONS TO SITE/CAMP - From Alturas, go north on US Hwy 395 approximately 20 miles to Davis Creek. Turn east on County Road 11 and continue north approximately 5 miles to the campground on the right.

VEHICLE REQ'S – High clearance needed, 4x4 recommended, & carpooling to difficult sites.

CAMP/FACILITIES – Neither water nor garbage are provided at Plum Valley Campground. There is a vault toilet, and there are fire rings. Bring enough water for drinking and washing up. Carry out trash and pet droppings on your own. Dogs must be on a leash. The closest town is Alturas, approximately 40 miles away.

TOOLS – Shovel, pick, rock hammer, pry bar, buckets & bags for material. Gloves, eye protection, and knee pads are a very good idea when picking up glass (obsidian).


SAFETY CONCERNS – Snakes, loose rock, dehydration (bring plenty of water), protection from the sun, sharp obsidian, and obsidian in the roadway (can damage tires).

CLIMATE/WEATHER – Generally hot and dry. Check weather in advance. It can rain this time of year.

CLOTHING – wear layers, hats and protection from the sun. Good shoes or hiking boots.

OTHER REMARKS – Obsidian is in the soil, and can damage tires, shoes, and most importantly kids' and pets' feet, so be aware.

FEES – **Permits are required at this site.** They are available for free at Davis Creek Store, located at 41942 Highway 395, Davis Creek, CA, or the USFS Modoc Office National Forest Office, at 800 W 12th St., Alturas, CA. However, I can get a permit for everyone who signs up in advance, if I know who you are. So please let me know in advance. Otherwise, you will be required to get your own permit.

Chipped Stone Bear



In 1985, an artifact made from volcanic rock was unearthed at an archaeological dig overlooking the Agua Hedionda Lagoon in Carlsbad, California, in San Diego County. Archaeologists noticed a 2.5” long by 1.5” piece of meta-volcanic rock that looked a lot like a bear. It was fashioned by California Indians around 7,000 to 8,000 years ago. The unique shape gave speculation that the small item might have had some religious connotations to the local members of the Luiseño and Juaneño Indian Tribes. The “Chipped Stone Bear” is the Official California State Prehistoric Artifact as adopted in 1991.



The Rarest of Minerals

More than 4,400 mineral species are found in nature. Some mineral collectors are species collectors who try to build a collection with as many of these species as possible. It is safe to say that no one has ever collected every known mineral, nor does any museum have a complete collection. New species are found and described each year and many mineral species are quite rare. Many of these species are known only from a few "spots on rocks" at their discovery site – usually referred to as the "type locality".

What is the rarest mineral of all? Many candidates could be submitted for this honor. For some rare species, rarity is really a function of the inaccessibility of the collecting site. Tranquillityite, from the Mare Tranquillitatis (Sea of Tranquillity) on the Moon is undoubtedly one of the rarest of all minerals. It is a dark red-brown hexagonal mineral with the interesting formula $(\text{Fe}^{2+}, \text{Ca})_8(\text{Zr}, \text{Y})_2\text{Ti}_3(\text{SiO}_4)_3\text{O}_4$, but it is its origin more than the structure that makes it rare. Apollo astronauts collected it and it is unlikely that any additional samples will be collected soon. Whether or not it is truly rare on the Moon is a separate question – for all we know, the Moon could be crawling with the stuff.




Another extreme rarity is ernstburkeite, a trigonal magnesium methane sulfonate hydrate, $\text{Mg}(\text{CH}_3\text{SO}_3)_2 \cdot 12\text{H}_2\text{O}$. Although this compound is known syntheti-

cally (i.e., it can be made in a lab), it has only been found in nature in Antarctica. It was found as a small (0.005 mm) inclusion in an ice core taken from a depth of 577 m below the Dome Fuji Base on the East Dronning Maud Plateau in East Antarctica. Not exactly the site of your next field trip!



It is interesting to note that rarity does not always create value. You may have the world's largest specimen of "whatchamaycallitite" a 1 mm-long beauty of a species which is known from only five almost microscopic crystals found in one locality (which just happens to be in your backyard). But chances are good that you won't be able to sell that specimen for anywhere near the price of a modest 1-cm rhodochrosite from the Sweet Home Mine, Colorado.
