Old Business – Financial report of expenses and income for the Lapidary Shop provided by Fran Todd. Fran provided information on income and expenses for the shop. Suggestions were made for increasing the income and for accounting the amount of money received for various rock sales. Rocks around the Lapidary Shop should be sorted into classifications so that the more valuable rocks are charged more for selling prices. Increase the number of times we sell rocks. She also made suggestions regarding the recording of "line items". We should try to make the Shop "financially" pay for itself. Work on getting more volunteers to give classes and she proposed having the Shop open (with an instructor) on the 1st, 4th and 5th Tuesday nights. Suggested during nicer weather, to hold classes outside, such as knapping, dry polishing and broom casting. Shared was the way other Societies are having auctions of material, some live, some on-line or during an open house event. A motion was MSA to increase by \$5, starting Jan. 1<sup>st</sup>, the fee for the Introduction to Lapidary Classes, total fee would be \$50 and to increase the fee for other classes by \$5 (\$10 would go to the Society).

#### **New Business -**

Additional support for the Treasurer – discussed was creating the Chairperson position – Bookkeeper. The Book- keeper would not be a Treasurer. The Treasurer takes in money, has authority to sign and pay bills. The Bookkeeper would get accounting done, do the 990 tax form. This position would be created in the RRR Standing Rules along with listed duties. A motion was MSA to create under our Standing Rules, the position of Bookkeeper and to appoint Steve Smith. The motion was passed with one opposition. Further work on the Standing Rules will be done during the January Board Meeting and to make this official in January. Work can be done before then.

Budget for 2024 – discussion about creating a budget for the 2024 calendar year. At the Jan. Bd. Mtg. a proposed budget will be all inclusive, including the Show Budget.

Other Business – It was decided to advertise Mike Burkleo's sale of jade at his house on Dec. 9<sup>th</sup>. Vern will accept signups from members who plan to attend. An email will be sent out to the membership.

**Next Bd. Mtg.** – January 22, 2024. **Adjournment** – adjourned at 8:36 p.m.

## **Rockhound Soapbox by John Martin**

Public Lands Advisory Committee (PLAC) Report about the new proposed legislation, H. R. 5660: Chuckwalla National Monument Establishment and Joshua Tree National Park Expansion Act of 2023, which is composed of 700,000 acres of the California Desert covering 2 counties and extends from the southern edge of the Joshua Tree National Park to the California-Arizona Border.

The proposed Monument includes the Wiley Wells District which contains the Hauser Geode Beds and several other Geode Collecting Sites. If the legislation passes it could have an impact on Recreational Rockhounding. However in the proposed legislation is a paragraph on allowable recreational activities with in the Monument boundaries, Paragraph (4) Recreation states:

"The Secretary shall continue to authorize, maintain, and enhance recreation in the Monument, including, but not limited to, camping, hiking, backpacking, sightseeing, nature study, horseback riding, hunting, hang gliding, climbing, mountain biking and motorized recreation on authorized routes, and the noncommercial collecting of rocks, minerals, and semiprecious gemstones, so long as such recreational use is consistent with the purposes specified in section 4(b), this section, other applicable law (including regulations), applicable management plans, and input from the Commission regarding potential impacts to culturally sensitive sites and resources."

However, there are some other conditions which may make Recreational Rockhounding a thing of the past. There are outside activities and activist groups pushing that if the legislation fails to pass congress that the President use the Executive Order to Create the monument which would most likely not include the ability to continue Recreational Rockhounding. To make things worse, there are actions in progress in which the entire proposed Monument area of 700,000 acres will become an expansion of the Joshua Tree National Park, where there is No Removal of any Natural Resources for any reason, except by government agencies The collecting of Geodes will be no more. What can be done by Recreational Rockhounds to preserve the sites for continued collecting now and for future generations? Become Rockhound Activists! Read the proposed Legislation:

Contact/write your elected officials and let them know your position on the legislation. Contact the BLM and get their information on the Monument and ask that Recreational Rockhounding be included in the Monument Management Plan. Attend any meetings pertaining to the Monument, search the internet for any information on the monument legislation. Most of all make your voice heard and make the united voice of the Rockhounds across America be heard. If you remain a pacifist, you will lose your right to be a Recreational Rockhound.
